The General Services Administration's unrestricted government-wide acquisition contract Alliant 2 (GWAC) is a multiple-award, indefinite delivery/indefinite quantity (IDIQ) next-generation GWAC that federal agencies can use to purchase IT services. The contract has a \$75 billion contract ceiling and a five-year base period effective July 1, 2018 with one five-year option. This next generation GWAC offers comprehensive and flexible IT solutions worldwide, including new technologies that may emerge during the lifecycle of the task order.

Alliant 2 has earned a "Best in Class" status from the Office of Management and Budget, offering government agencies the choice to obtain customized, integrated IT solutions and access to "best in class" private sector IT services. The GWAC's scope includes big data, cloud computing, cybersecurity, agile development, biometrics and identity management, data center consolidation, health IT, modeling and simulation, mobile IT, web analytics, Internet of Things (IoT), virtual networking, and other related IT support services. Primary NAICS: 541512 – Computer Systems Design Services; task order scope is not limited to this NAICS Code.


